TOUGH PROBLEMS IN COMPUTATIONAL GEOMETRY

- Cancer doesn't grow
 "normally"
- Images and samples may be invasive to get
- Use AI and geometry to fill in the gaps



TOUGH PROBLEMS IN ANOMALY DETECTION

- Healthcare fraud estimated \$80 billion a year
 - 2.5 billion typically received

- Billing services not rendered forcing signature
- Upcoming of services / items
- Duplicate claims
- Unbundling
- Excessive services
- Unnecessary services
- Kickbacks rewards

AMAZON ECHO MURDER CASE

- "Wake word"
- "The heart of the First Amendment protection is the right to browse and purchase expensive materials anomalously, without fear of government discover."
- Listen not recoding

FACTS

Police discovered a man named Victor Collins dead in the back yard.

Collins' body had been floating face up in a hot tub, and his left eye and lips were dark and swollen, police records stated.

Bates, who had been the one to call 911 that morning, had told police that he and a few work buddies, including Collins, had stayed up the night before watching football and drinking. Bates agreed to let two of them crash at his house, he told police, then went to bed. Shortly after he awoke, Bates said he spotted Collins' lifeless body in the spa.

Upon further investigation, however, police began suspecting foul play: Broken knobs and bottles, as well as blood spots around the tub, suggested that there had been a struggle. A few days later, the Arkansas chief medical examiner ruled Collins' death a homicide — and police obtained a search warrant for Bates' home.
