It is my desire to release, effective November 15, the currently installed DSU-10 and I would like to write a letter to HISI requesting the removal.

The current needs are:

- 1. For recompilation of Fortran compiler
- 2. Possible backup for DSU170 program

In my opinion, I see no reason why recompilation should be necessary since we can always apply a caveat to the service to the effect that only changes which can be "patched" will be considered. The new Fortran is not that far off anyway. In addition I do not feel that anyone can honestly commit to using a single DSU-10 as a service system file storage device in view of the reliability statistics we generated last year.

If you can any reason why I should not release this system, please let's discuss before October 15, when I plan to write the letter to HISI.

We are fast approaching a time when payment for the use of Multics hardware to Honeywell Information Systems Incorporated will be more than just machine rental but will include the revenue sharing provision described in the contract. As things now stand, we will definitely be making such payments beginning January 1971.

In this regard I am asking Tom Van Vleck to expand slightly the "Multics Billing Summary Report" to include a statement of "Gross Sales of Systems Use". This particular contractual term represents that amount of actual billing for Multics use to accounts other than Multics Development, Phoenix, SysLib, SysDaemon, SysAdmin, SysMaintenance, Operators, Terminals, etc. As various of these types of accounts get added and deleted, the monthly statement will automatically reflect the actions and no manual manipulation will be necessary on your part.
