1. TERM

a: This Agreement shall be effective at the time the 645 Follow-on equipment is turned over to MIT according to the Honeywell/MIT Agreement No. 714-C5 and shall continue for an initial term of one (1) year and shall remain in full force thereafter until terminated. This Agreement may be terminated at the end of the initial term specified above or at any time thereafter, by either party, upon ninety (90) days prior written notice.

2. STANDARD SERVICE

a. MIT agrees to furnish Client fifteen (15) guaranteed lines to the full MULTICS facility.

3. BOOTLOAD SERVICE

- a. MIT agrees to furnish a combination of equipment subsystems adequate to generate and test (bootload) new versions of MULTICS. Client will be able to access a minimum of one (1) of each of the MULTICS hardware subsystems as required for each bootload.
- b. MIT agrees to furnish Client a minimum average of three (3) hours per day of prime shift usage for bootloading.
- c. MIT agrees to furnish Client a minimum average of three (3) hours per day of off-shift usage for bootloading.

4. CHARGES

- a. Client agrees to buy FULL MULTICS Service at the then current MIT user rates. In addition, Client agrees to buy bootloading time at the rate of \$160.00 per hour for the first shift, \$120.00 per hour for the second shift, \$80.00 per hour for the third shift and \$100.00 per hour for the fourth shift.
- b. Client agrees to buy a minimum of \$404,400 of service, as set forth in 2. and 3. above, per year. If Client usage totals less than this minimum over the initial term of this Agreement as set forth in 1.a., or averages

less than \$33,700 per month over any subsequent term, Client will be billed for the difference between actual usage and the minimum at the end of the initial term of this agreement and yearly thereafter, or at the end of the final month of the agreement if the agreement is terminated at a fraction of a year.

c. Total service and bootload charges will be billed on the day of each month for the previous month's service. Client will credit such charges to the total monthly rental charges being billed to MIT for the following month under Honeywell/MIT Agreement No. 714-C5.

5. GENERAL

This agreement shall be governed by the laws of the Commonwealth of Massachusetts.
