

This additional equipment has actually replaced similar equipment of a Mod A variety. It brings your complement of hardware installed equal to the equipment list contained in our agreement dated April 22, 1968, with two exceptions. These exceptions are that you now have installed six (6) 120 KC magnetic tapes rather than the 60 KC tapes called for in the original agreement and the RACE unit has not yet been turned over.

As of this date, all equipment contractually called for (except RACE) has been delivered, tested, and installed.

Rent on this new equipment will commence on November 1, 1968, as per our contract terms.
