
Dear Professor Braida:

Project MAC would like to request a three-month summer appointment for Professor William A. Martin. This letter explains the reason why this exceptional request is being made.

Project MAC has recently received approval from its sponsoring agency, ARPA, for a major redirection of its research goals, with about half of its ARPA funds to be committed to the new area, Automatic Programming. Professor Martin has agreed to provide most of the leadership for this new project, including especially the management of the starting up phase. Substantial funding of the new project area began in June, 1972, and an intensive effort by Professor Martin will be necessary for the next several months to get appropriate projects going, and most importantly, to develop a level of redirection of Project MAC effort which is consistent with that promised to the sponsor.

For these reasons, we feel that an exceptional situation exists, and a request for a three-month summer appointment is appropriate.

Dear Professor Braida:

I have reviewed your request of June 16 to permit Professor W. A. Martin to have a three month summer appointment. As you know, Section 2.14 of Policies and Procedures states that:

"In order to insure the availability of at least one month for rest and relaxation for all of the teaching staff, no individual will be paid more than eleven-ninths of his annual plan salary in one fiscal year. This applies to all individuals receiving supplementary summer compensation for additional teaching duties as well as sponsored research. Only for the most exceptional reasons will there be any departure from this policy."

Neither your memorandum or that of Professor Fredkin indicates that there is anything exceptional about Professor Martin's plans for the summer. Therefore, I have no alternative except to reject your request.

If you care to resubmit it, the case should be based upon a need for the research to be done in this time period. Also, the benefits to the department should be clearly indicated.
